

On behalf of the CAPNEMO staff, board and policy council members, I am pleased to share this 2016 Annual Report with you.

Utilizing the dedication, innovation and imagination of 98 employees, 15 members of the Board of Directors and 14 members of the Head Start Policy Council, CAPNEMO continues to provide over \$4.3 million dollars in services to 1,340 households with the majority being single person and single parent households with employment as the primary source of income. These households were assisted with services such as: Weatherization, Head Start, Low-Income Heating Assistance Program (LIHEAP), Community Services Block Grant (CSBG) projects and rental assistance. These programs work to assist families with removing obstacles that prevent them from becoming self-sufficient. This evidence has proven that the typical customer served by the agency has transitioned over the last several years to become today's working class.

Our annual report highlights the positive changes that were made during the past year within our local communities and in the lives of our residents. We plan to continue providing quality needed services and projects to ensure that the needs are addressed and met to improve our local communities.


Agency Outcomes

- 65 homes were weatherized through the Weatherization Program
- 306 early childhood opportunities were preserved by the Head Start Program
- 224 children received immunizations, dental and medical screenings
- 375 children participated in pre-school activities to develop school readiness skills
- 79 children were entered kindergarten developmentally ready
- 44,406 volunteer hours were contributed to the agency with 34,467 hours contributed by low-income individuals
- 138 Senior Citizen individuals received assistance with their heating bill
- 455 disabled individuals were assisted with their heating bill
- 2,621 individuals received assistance with their heating/cooling bills
- 18 families obtained safe and affordable housing through
 Section 8
- 11 families received food assistance
- 18 employed individuals obtained an increase in employment income and/or benefits
- 8 participants that were unemployed obtained employment
- 1,200 pounds of food grown at the community garden
