## *Executive Summary*

---

### **Purpose**

The purpose of Community Action Partnership of Northeast Missouri (CAPNEMO) community needs assessment is to provide information about the greatest needs of our community that lie in our five-county service area, which include Adair, Clark, Knox, Schuyler, and Scotland.

The report allows us to have a better understanding about the needs of the community, such as what the need is and why the need may exist. The assessment allows CAPNEMO to meet with community members thru focus groups as well as collect data thru online and paper surveys. The assessment allows us to see what each county has a need that we might not be addressing or if all of our service area is struggling with the same issues

### **Approach**

CAPNEMO's approach to developing the Community Needs Assessment began with the collection of qualitative and quantitative data. Community Action Partnership of Northeast Missouri (CAPNEMO) distributed an online community needs assessment survey to staff, community partners, clients, and publicly on social media. The data used for this 2023 Community Needs Assessment includes:

### **Clients' Needs Assessment Survey**

- Community Focus Groups
- Community Needs Survey
- U.S. Census Bureau
- Other quantitative data sources

Quantitative data included is from the Census, the MOCAN Network, Department of Social Services, and Department of Elementary and Secondary Education are included in this analysis. Data from each of these sources were collected at the federal, state and county level as data was available, there was data not available at all levels. The data show the picture as whole and not on a lower level explaining the cause of why it is happening or what is the cause of the issue with poverty.

Qualitative data was collected from focus groups with our interagency, business partners and community members twice in May and June of 2023 via Zoom. Each focus group was asked to discuss which 3 of the following domains they felt was the most of concern to the community they are in: Employment, Education, Health, Housing, Income, Nutrition, Transportation. Only a few community partners participated in these focus groups. It was difficult to gather much information due to lack of participation from partners and no community members.

The information was collected from a verity of organizations in the five counties such as, faith-based, private sector, public sector and educational sector. After the completion of data collection, all the information was reviewed and summarized to list the key findings below.

This information was shared with the CAPNEMO governing board and staff as well as on our website for the public to view.

Affordable safe housing  
Education (Life Skills/Re-entry program)  
Lack of transportation  
Nutrition  
Affordable Child Care

## **Housing**

Individuals indicated that housing related issues are top concern in our communities.

Affordable, safe housing availability and the high cost of rent. This does include

affordable rental units that accept housing vouchers, lack of income based rental properties or, lack of home repair assistance for homeowners and lack of programs assisting mortgage assistance such as down payments or mortgage education. Program participants identify felony restrictions for renters, cost of home repair and past evictions are some of the major barriers individual face when obtaining housing.

## **Education (Life Skills/Re-Entry)**

The lack of job readiness skill, jobs available for unskilled workers in our community members to afford basic necessities such as rent and utilities, affordable childcare, nutritious foods, or car maintenance. Individuals who are re-entering society lack basic budgeting skills, cooking skills, social skills, and job readiness skills to be a productive person in society.

Individuals lack high school diplomas, secondary educational, and employment skills contributes to the cause of poverty.



## **Transportation**

The issue of transportation was indicated as a significant issue by our clients and others in the communities. Clients indicated that lack of affordable and reliable transportation was one of the top issues which prevents people from getting to work and seek health care. CAPNEMO staff have stated that there are several clients whom have stated that they cannot gain or maintain employment because they lack reliable transportation. Nearly 90% of our clients indicated that they have no emergency funds to pay for repairs if their vehicle needs repairs.

CAPNEMO developed a transportation program in FY21 that has been a success and is growing each year. The program has been as to assist community members whom are currently employed with the cost of car maintenance and repairs to stay employed or seek employment as well seek healthcare as needed.

## **Nutrition**

The common cause of poverty in this area is low wage earners or the cost of food and they are unable to afford nutritious foods. While the need for a nutrition and food programs persist in our service area, we are seeing a growing need in the others as well, due to the lack of availability of food pantries throughout our service area. CAPNEMO will continue to support and partner with area food pantries, while working to develop a possible food program for the agency as well.

## **Affordable Child Care**

This lack of reliable, affordable childcare is a concern not only in our communities but nationwide. This has effects for parents, employers, and even on the economy. Most families struggle to find child in areas that accept children of ages 6 weeks to 12 years of age all year. The other struggle is that families can pay up to 50% or more of their net pay for child care which contributes to issues of poverty.

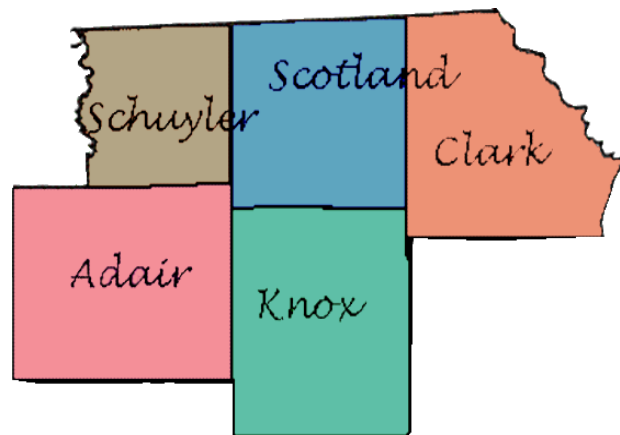

## *Missouri Community Action Network Report*

The Community Action Partnership of Northeast Missouri presently serves around 44,624 people in the 2,319.75 square mile report area defined for this assessment according to the U.S. Census Bureau American Community Survey 2018-22 5-year estimates. The population density for this area, estimated at 19 persons per square mile, is less than the national average population density of 93 persons per square mile. The majority of this population is located within Adair County and was found to be the majority of our respondents per our Community Survey. Our Community Survey was distributed among CAPNEMO Staff, Head Start Parents, Board Members, Business Owners, Social Services-Related Employees, advertised on social media platforms, available to individuals via mail and as well as physical copies to all residents that lived within the counties we served.



## **Population Profile**

### **Population Change**

Population change within the report area from 2010-2020 is shown below. During this ten-year period, total population estimates for the report area declined by -3.71 percent, decreasing from 46,151 persons in 2010 to 44,440 persons in 2020.

## Households in Poverty

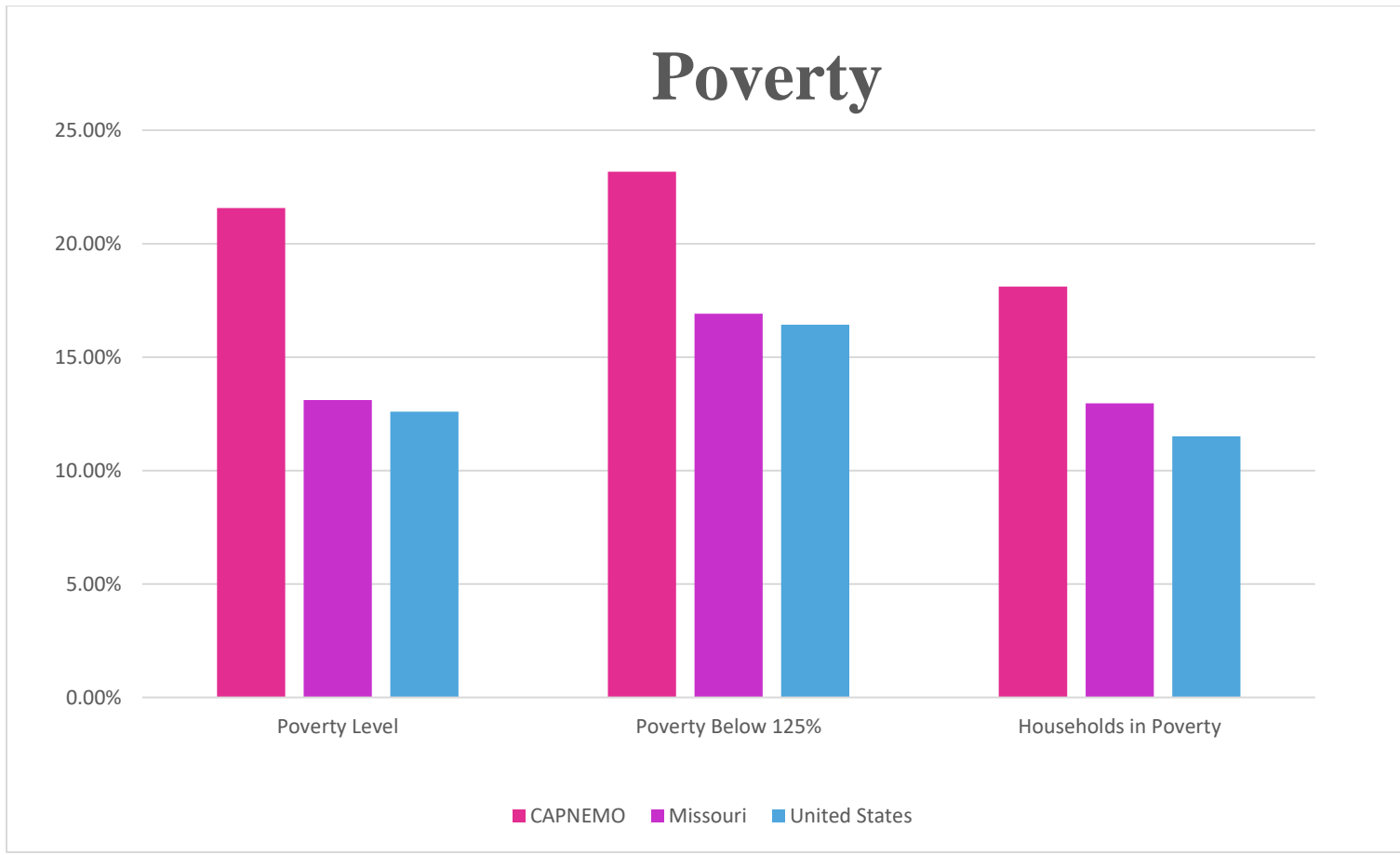

## **Adult Literacy**

## **Adult Literacy Level 2**

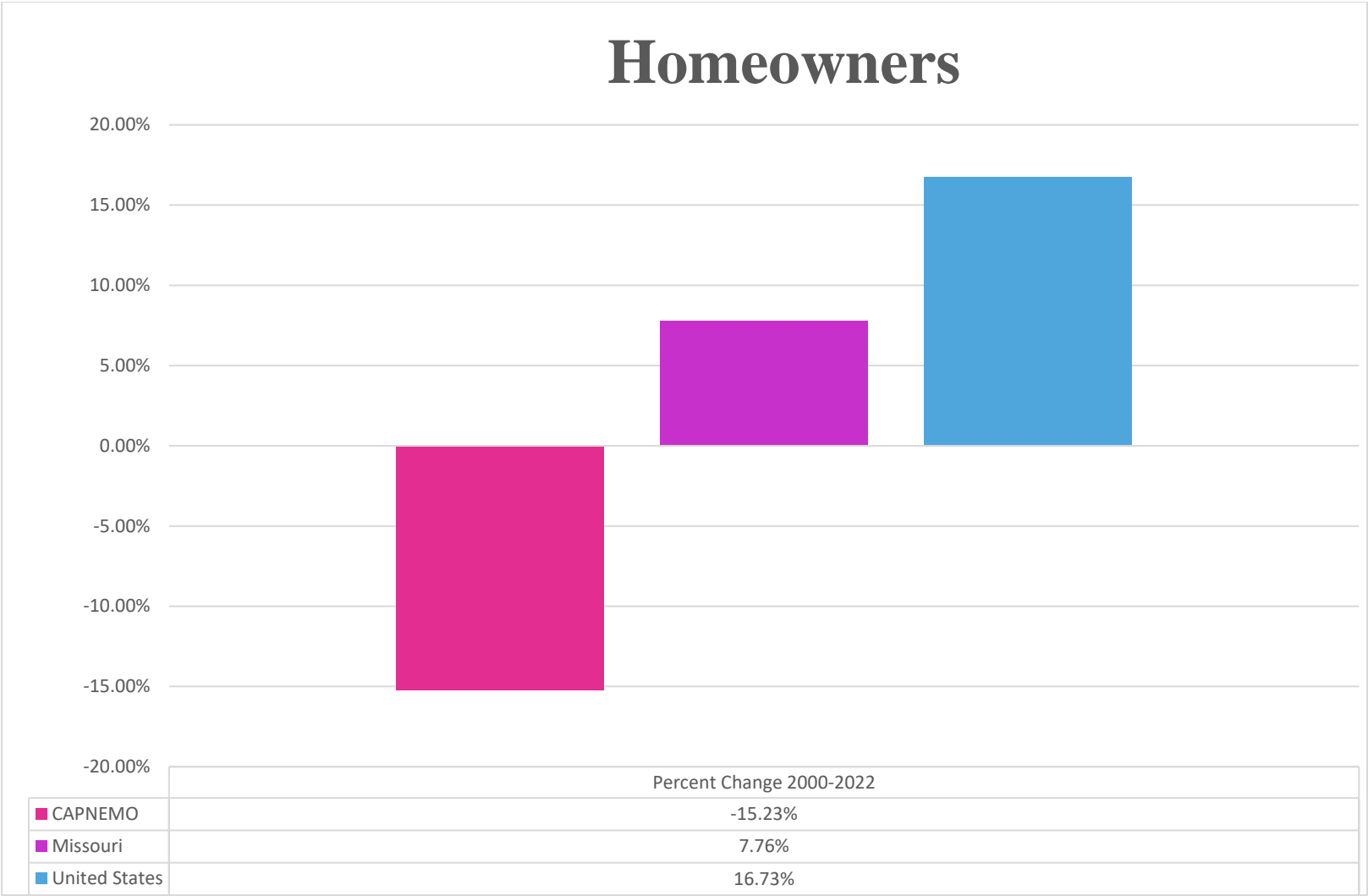

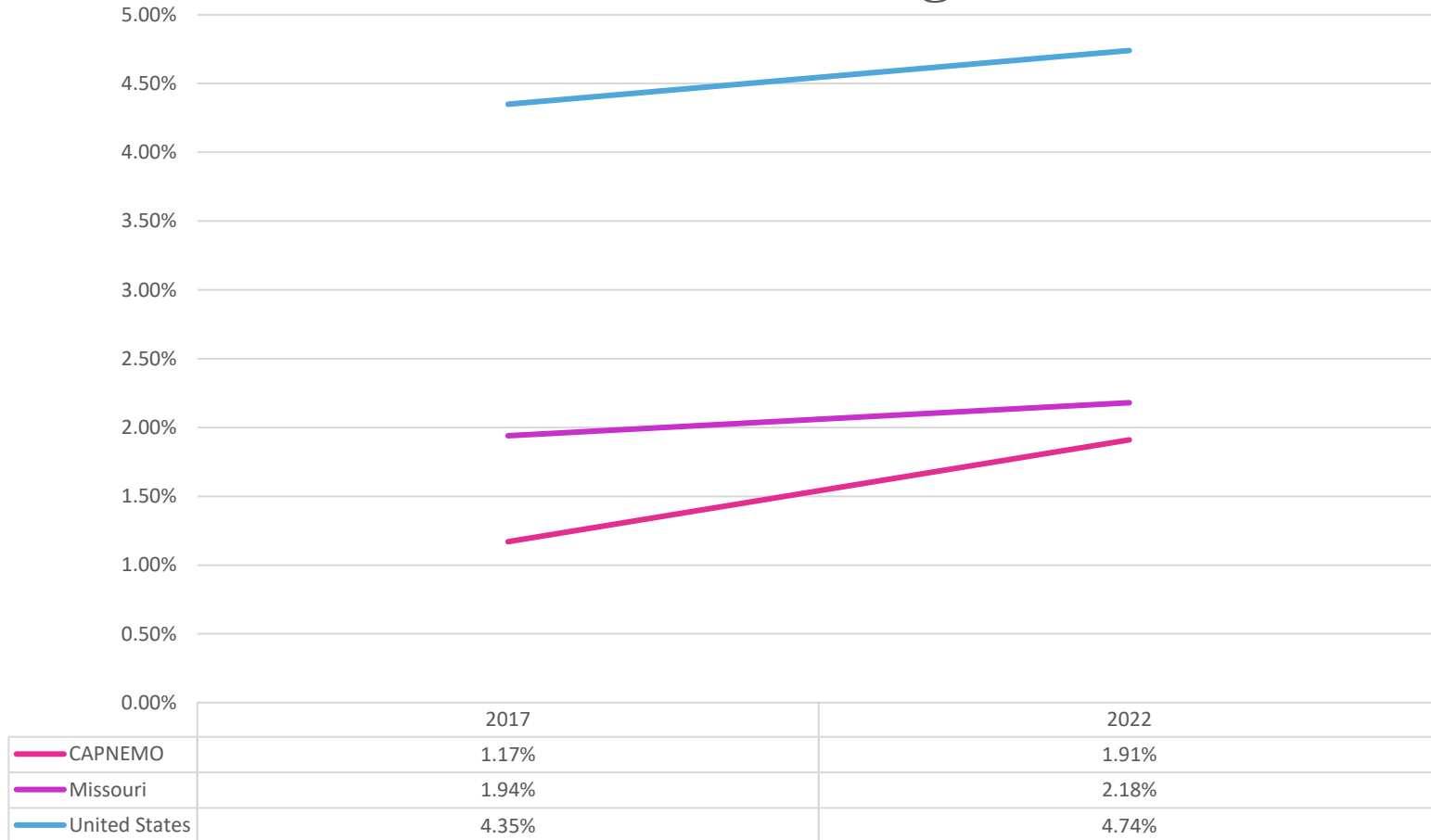

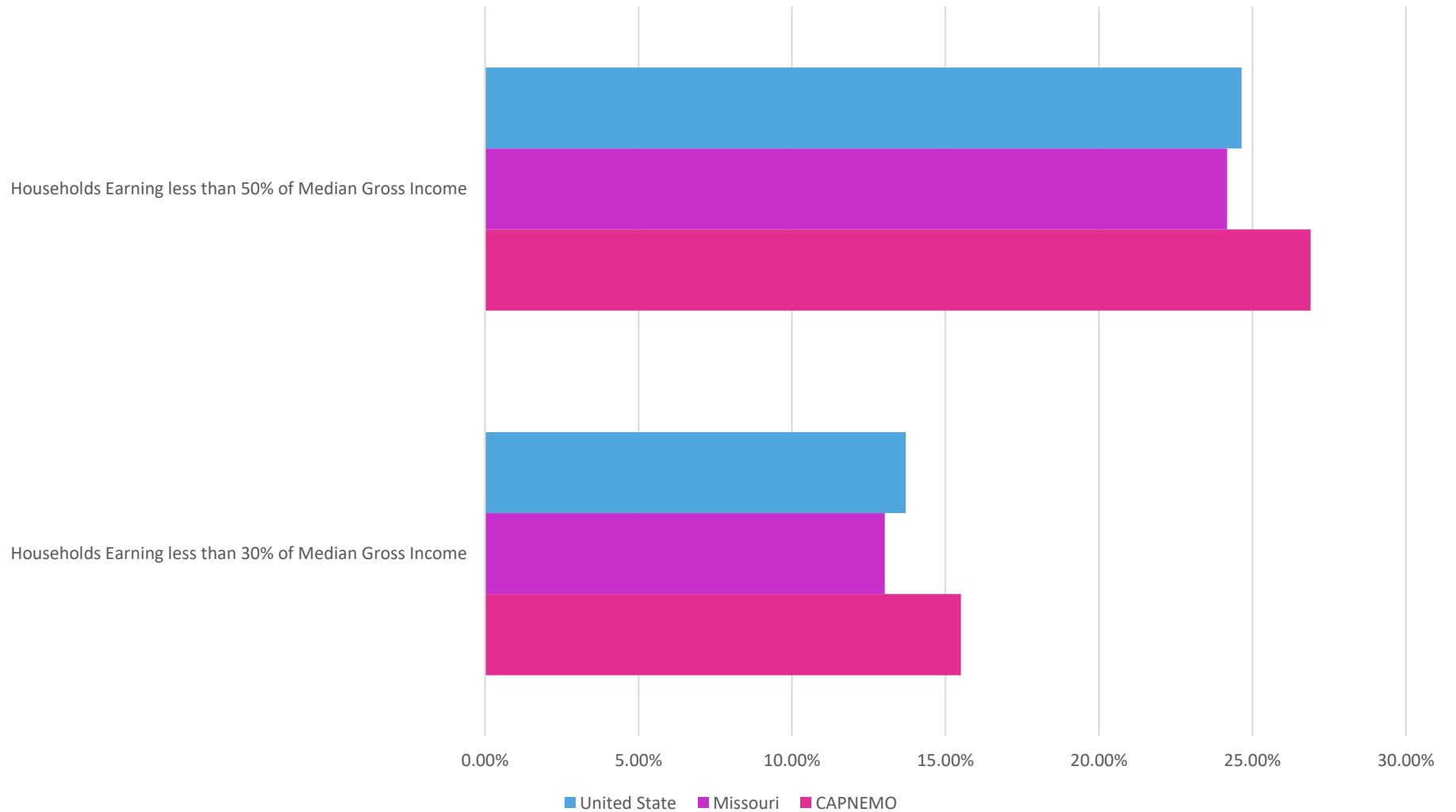

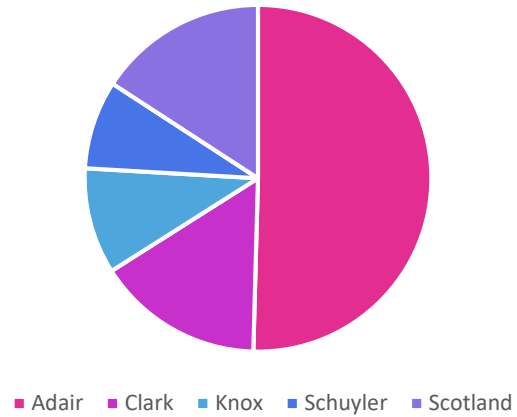

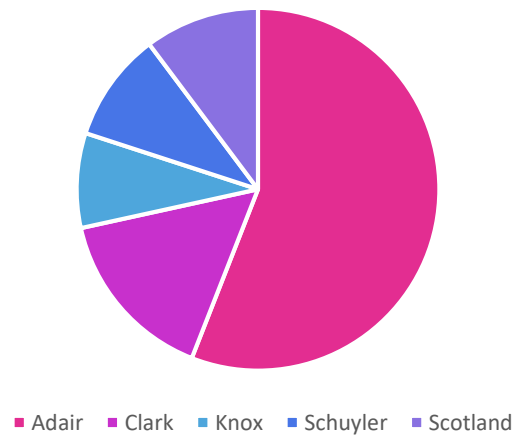
